The purpose of the corporation is to engage in the following business activities:

THE CORPORATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, EDUCATIONAL PURPOSES, INCLUDING, FOR SUCH PURPOSES, THE MAKING OF DISTRIBUTIONS TO ORGANIZATIONS THAT QUALIFY AS EXEMPT ORGANIZATIONS UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.MORE SPECIFICALLY, THE CORPORATION'S PURPOSES FOCUS ON THE LITERACY AND EDUCATION COMPONENTS OF IRS NONPROFIT 501(C)(3) CLASSIFICATIONS. AMONG OTHER LAWFUL ACTIVITIES, THE CORPORATION MAY PROVIDE FUNDING FOR PROGRAMS OFFERED BY THE STAFF OF THE MIDDLEBOROUGH PUBLIC LIBRARY AND ENHANCE AND ENLIVEN THE EXPERIENCE OF LIBRARY USERS. IT MAY SPONSOR EDUCATIONAL AND CULTURAL PROGRAMS FOR ADULTS, TEENS, AND CHILDREN, AND MAY PARTNER WITH OTHER ORGANIZATIONS TO BENEFIT THE COMMUNITY AT LARGE. THE CORPORATION WILL ATTEMPT TO BUILD A STRONG NETWORK OF VOLUNTEERS, DONORS, AND PARTNERS WHO ASPIRE TO PROMOTE EDUCATION, COMMUNITY ENGAGEMENT, AND CULTURAL PRESERVATION, THEREBY IMPACTING THE QUALITY OF LIFE FOR RESIDENTS OF MI
